



Brighton i360 Walk360 Waiver

PLEASE READ AND SIGN TO ACCEPT OUR TERMS DETAILED BELOW.

- Participants must be aged 12 or over. Those aged between 12 and 17 must be
 accompanied by a parent or legal guardian, on a ratio of 1 adult to up to 2 children.
 Accompanying parents or guardians must sign the parental / guardian consent section
 of this form for each child in their care.
- 2. All participants must be capable of understanding and following instructions given by the Brighton i360 team.
- 3. There is a weight limit of 125kg excluding equipment provided to you.
- 4. Due to the nature of this event, all participants are expected to be in good health and have a satisfactory level of physical fitness. The access to the BA i360 Pod roof requires a short climb on a vertical ladder before transferring to the roof where you will be attached to the safety systems. If participants are unable to climb the ladder or transfer to the pod roof no refund shall be given.
- 5. All participants are required to pay special attention to the safety brief provided before boarding the Pod, once completed there will be an opportunity to ask any questions you may have.
- 6. Brighton i360 staff will accompany participants throughout the duration of the event.
- 7. All participants will be required to wear a safety harness and helmet provided by Brighton i360 before climbing the ladder up to the Pod roof.
- 8. All participants should wear suitable clothing that will allow you to wear a harness over the top and will not restrict your movement or lead to overheating in warm conditions. The Walk360 takes place on a glass roof so additional rubber overshoes are provided for both extra grip and to avoid accidental damage to the glass panels.
- 9. All participants should wear practical footwear (no high heels or open toe).
- 10. No loose items will be permitted on your person whilst walking on the Pod roof.
- 11. We love to see your photos of you enjoying the Walk360 although we do have specific rules about using your phone during the experience to minimise risk of damage and injury. We ask that you always observe these rules. Participants can use their mobile phones during the Walk 360. All phones will be placed in a locked clear pouch and





- attached to each participant by a locked cord. Phones must not be removed from the locked pouch by the participant and can only be removed by one of our trained instructors once you have completed the Walk360. Selfie sticks are not permitted.
- 12. No bags will be permitted inside the Pod during the event. All bags must be left in the main building in a secure area until the event finishes. All belongings will be left entirely at your own risk. Brighton i360 will not accept responsibility for any losses or damage that may occur.
- 13. Brighton i360 has the right to stop the experience at any time following any unsafe or negligent behaviour from participants.
- 14. Brighton i360 has the right to refuse entry without refund to participants who have not complied with these conditions both before and during the Walk360.
- 15. Brighton i360 take no responsibility for accidents that may occur during this event because of negligence on behalf of the participant.
- 16. Participants must not be under the influence of alcohol or legal or illegal substances which would make it unsafe for them to participate in the Walk360 or to understand the Safety Briefing on the day of the event. Participants may be asked to perform a breathalyser test before they board the Pod. Alcohol will only be served to participants from the Sky Bar on the Pod once they have completed the Walk360 and have had their safety equipment and identity band removed.
- 17. The Walk360 will take place in winds of up to 15 metres per second (measured at the top of the tower). We will not operate the event in winds more than 15m/s, during lightning storms, heavy snow, ice, or extreme weather conditions which we believe might make it unsafe to walk on the glass roof. If we must cancel an event due to weather conditions, tickets will be extended by three months.
- 18. Due to the live operational nature of Brighton i360, it is possible that advertised dates and timings may be altered. The effect on dates and timings is likely to be minimal, and participants will be contacted at the earliest opportunity via email if their scheduled Walk360 is affected. When a service cannot be provided, ticket holders will be informed, and tickets will be extended by three months.





- 19. When participants arrive late for a Walk360 event, every effort will be made to include them in the activity. However, due to the live operational nature of Brighton i360, if late participants cannot be accommodated on the Walk360, their ticket is non-refundable.
- 20. Toilet facilities are not available during the Walk360 but are available to use within the Brighton i360 building and The Deck before and after the experience.
